I understand that any violation may result in immediate expulsion from these activities.

The New Mexico Department of Game & Fish disclaims any Tort Liability for the signed participant. If any injury is sustained by a participant or instructor during the above-described program, evidence of negligence must be proven against the Contractor, Department of Game & Fish or State of New Mexico before a claim will be accepted. Also, the State of New Mexico, Risk Management Division will not assume any liability between one participant and another.. Neither the Contractor, the New Mexico Department of Game and Fish, nor the State of New Mexico waive any defenses or immunities contained in the Tort Claims Act. 42-1-1 et seq N.M.S.A (1978).

On my own behalf and on behalf of my heirs, next of kin, executors, administrators, estate, agents and assigns, and representatives of any nature whatsoever, for and in consideration of the authorization and permission to accompany New Mexico Department of Game and Fish officer(s) or other Department personnel during the course of their duties, which authorization and permission has been granted to me at my voluntary request, after having been fully advised of the potential hazards of such activity or activities do hereby WAIVE AND RELEASE all demands, damages, actions, causes of actions, suits and claims of any nature whatsoever, and costs (including attorneys' fees) whether in law or is equity, that I or my heirs, next of kin, executors, administrators, estate, agents and assigns, and representatives of any nature whatsoever might otherwise have against the State Game Commission, the Department of Game and Fish and their respective agents, employees and representatives, on account of my death or injuries, both to person and to property, whether foreseeable or not, which may occur, directly or indirectly, or develop at anytime in the future as a result of my activities or association with the New Mexico Department of Game and Fish YHEC program coaches training and participation in the above-described YHEC program.
